MONTHLY MEETING MINUTES

The September 13, 2021 meeting was called to order at 7:05 pm by President, Mike Powers.

Opening ceremonies were conducted.

Roll Call: There were 10 members and 1 guest present

Secretary's Report: The August Minutes were read. Steve made a motion to accept, Bill seconded the motion and it was carried.

Treasurer's Report: A full copy of the Treasurer's Report is available to members upon request, if anyone would like to review it.

Road Captain's Report: Bob reminded everyone about the upcoming benefit ride for the Troy Fire Department on September 19th. This is the final benefit ride of the season.

Membership Chairman's Report: Carl said we are at 91%. We have 34 members and will be losing 2 at the end of the year. He reminded everyone that our 2022 ALR Dues are now due.

Old Business: Mike opened the discussion regarding the proceeds from the Bradford County Veterans Memorial Park ride. It was decided to add \$44 to the \$406 in proceeds to make a total donation of \$450. Bob made a motion to give \$450, Jodi seconded it and the motion carried.

Bob will set up a check presentation with Rainbow Riders and Animal Care Sanctuary. Mike will make arrangements with Chris Bogg from the Bradford County Veterans Memorial Park. They will try to coordinate this for our October meeting.

Mike reminded us that we have one more Bike Night coming up at the end of September.

Bill made a motion to give Keith and Jeni a \$150 gift card as a Thank You for the use of their truck and trailer all season as a chase vehicle. Nancy seconded and the motion carried.

Nancy read the breakdown of the proceeds and expenses for our Veterans Relief Fund ride. After all was said and done, we made \$1,609.47 which has been deposited into the Relief Fund account.

Jodi discussed the possibility of the Riders donating to the Auxiliary toward the cost of another table for the outside dining area. Jodi made a motion to donate \$500, Bill seconded the motion and it carried.

New Business: Jodi presented a request from the Auxiliary for a donation toward their new shed. Carl made a motion that we donate \$500, Bill seconded the motion and it carried. Jodi will ask the Auxiliary if we can use a corner for storage of our items.

Correspondence: We received a notice that the dates for the Annual Legion College will be October 30th at Cumberland Valley Eagleview Middle School in East Mechanicsburg or November 6th at Latrobe High School in West Latrobe. Cost is \$20 per person and Registration Forms are on our website. Registration deadline is October 16th.

We received notice that the PA American Legion POW/MIA Remembrance Ceremony will be held on September 17th at 10 am in the Soldiers Grove behind the Capitol Building in Harrisburg.
